





LONDON, Dec 6 (Reuters) - Britain's Serious Fraud Office said it made one arrest on Wednesday after launching a criminal investigation into allegations that London-based firm AOG Technics had distributed fake parts for aircraft engines.

The SFO said it raided an address in the London area and seized material about possible fraud by AOG Technics, which is accused of supplying falsely documented parts for use in the world's most-sold passenger jet engine, the CFM56.





When a CFE fails to comply with the Organization's Code of Professional Ethics – it means there is an ethical lapse.



Chevron v. NRDC decided in 1984. 40 years ago (Natural Resources Defense Council)

Courts should defer to administrative agencies' interpretation of laws when the statutory text is silent or ambiguous.

In Practice – license for Congress to write vague laws that delegate legislative power to admin agencies

Congress Declined Funding NMFS Decided that Fisheries Foot total Cost

Family-Owned herring fisheries & vessel operators are challenging an obscure Commerce rule {1976 Magnuson-Stevens ACT} regulates fishery management and permits the National Marine Fisheries Service (NMFS) AGENCY that requires vessels to carry federal observers to enforce its regulations but only in narrow circumstances does the ACT require fisheries pay for federal monitors

So Where is the Ethical Violation?

Congressional members are elected - Bureaucrats are not elected

Government Defunded the Program MFNS (Agency) Ruling: all All Cost going forward will be paid by fisheries

- 2) Ethics can provide help to adjudicate between conflicting principles.
- 3) People may have inadequate beliefs "Caveat Emptor."

- 5) Learn to identify the basic ethical principles in order to grasp the underlying structure of ethical reasoning.

Internal Revenue Service Criminal Investigation unit has identified ongoing fraud and scams related to the ERC that, to date, have resulted in 323 investigations involving more than \$2.8 billion of potentially fraudulent ERC claims throughout tax years 2020, 2021, 2022, and 2023. {Nov 22, 2023}

UNIMPLOYMENT - FRAUD

Comptroller Tom DiNapoli estimated that New York's Unimployment Insurance system lost at least \$11 billion to fraud between April 2020 and March of 2021

Congresswoman Nicole Malliotakis (NY-11), \$11 billion in fraudulent unemployment benefits since FEB. 23 since 2020. Estimates of \$400 billion for the entire country.

► Estimates for California are between \$30 – \$40 billion

CFE Code of 1/17/2018 Professional Standards

Section I - These Standards express basic principles of ethical behavior to guide members in the fulfilling of their duties and obligations.

Section II - Fraud Examination — assignment or engagement, a substantial purpose of which involves the PREVENTION, DETECTION, INVESTIGATION, or resolution of fraud or fraud-related conduct.

Integrity and Objectivity Section III Part A

CFE's shall not sacrifice integrity to serve client, employer, public

CFE's shall investigate for actual, potential, and perceived conflicts of interests

CFE's shall maintain objectivity throughout the fraud examination

CFE's shall not commit acts discreditable to the ACFE

CFE's shall not make a false statement when testifying under oath

OBJECTIVITY *

"...ability to conduct fraud examinations without being influenced by one's own personal feelings ...

and is not influenced by bias, prejudice, or other information that cannot be substantiated or that has no foundation."

BIAS - PREJUDICE

"Bias refers to partiality that prevents an individual from objectively considering an issue or situation..."

"...whereas prejudice refers to a preconceived attitude, belief, or feeling that prevents objective consideration of an issues or situation."

MORAL COMPASS

EACH OF US IS GUIDED BY OUR OWN "MORAL COMPASS."

Ethics Check 5 Questions to Ask

From the authors of The Responsible Manager: Practical Strategies for Ethical Decision Making, Michael Rion

Is this really an ethical dilemma? Are there competing interests involved? What principles & rules are applicable? Clarify issue in terms of fairness & integrity

2. Who else matters?

Who are the Stakeholders
What impact will my decision have on them?

Remember the Golden "Rule"

3. Is this really my problem?

Question of responsibility & obligation Extent of responsibility – me – boss – others?

Moral obligation or just a good deed Above and beyond the call of duty situation?

4. What do others think?

Get opinions from others
Other important information
Elicits facts, principle, & perspectives
Seek out well informed professionals

5. Am I being true to myself? Check on decisions ethical validity **Decision ethically justified?** Am I happy with my decision? **Consistent with Code of Professional Conduct** How would I feel if decision reported in newspaper

Ethics Check Six Step Process

- STEP 1 Recognize and define the problem
- **STEP 2 Determine the facts**
- STEP 3 Identify alternatives
- STEP 4 Apply ethical principles
- STEP 5 Make a final decision
- STEP 6 Communicate the decision


